Madam/Sir,

This has reference to the proposal submitted by Amrutvahini College of Engineering, Sangamner, Ahmednagar affiliated to Savitribai Phule Pune University, Pune for conferment of autonomous status.

The Commission, in its meeting held on 23.12.2024 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status on Amrutvahini College of Engineering, Sangamner, Ahmednagar – 422608 Maharashtra for a period of 10 years from the academic year 2025-2026 to 2034-2035 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The University is, therefore, requested to issue the necessary notification within 30 days regarding the grant of autonomous status to the College as per above mentioned UGC Regulations.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges, 2023. The Regulations are available on www.ugc.gov.in. Non-compliance of the requirements and conditions prescribed in the said Regulations shall attract action as per Clause -13 of the UGC Regulations, 2023. The college shall apply to the University Grants Commission for an extension of autonomous status at least three months before the completion of the period of autonomy.

Non-compliance of the above shall attract action as per Clause -13 of the UGC Regulations, 2023.
